## Valley Yoga Fest - Vendor Agreement

Date of Event: Saturday, August 11th, 2018

### Vendor Opportunities-

Home Based/Commercial Business: ONE 8' table with assigned spot- \$25.00

Vendors MUST staff their table the entire time during Valley Yoga Fest (Saturday, Aug. 11th, 9am - 5pm)

We allow only one representative per home based business and reserve the right to limit the number of similar vendors. The YogaFest Committee reserves the right to return any application submitted if we feel it does not fit the spirit of the event we are trying to achieve. If not accepted as a Vendor, we invite you to be a Sponsor (details below).

1. Assignment of Vendor Space: Vendors will be assigned their space on a first paid basis. We reserve the right to relocate booths at any time for the betterment of the event.

2. Payment for Vendor Space: PAYMENT IN FULL WITH COMPLETED VENDOR FORM. FIRST COME, FIRST SERVED OR UNTIL SPACES SOLD OUT. Any returned cheque will be charged a \$15.00 fee. Failure to pay the appropriate fee will result in loss of vendor space.

3. Vendor Hours of Setup and Operations:

- Saturday, 9am-10am. Event will begin at 10:00am and run until approximately 8:00pm. Vendor agrees to vend until 5pm but has option to stay until end of event.
- Vendors are responsible for CLEANING UP their spaces

• YOU MUST STAFF YOUR SPACE - We are not responsible for lost or stolen products or display items.

4. Liability and Insurance: Vendor shall protect the Valley Yoga Fest Committee and all Volunteers, and to save them harmless from any and all claims for damage or lawsuits which may arise from injury, as well as lost or damage to property or persons occurring within the space occupied by the vendor. Valley Yoga Fest Committee and all Volunteers shall not be responsible for the safety of any exhibit or vendor property in the case of loss by fire, robbery, theft, accident or any other destructive cause or for any injury that might occur to the vendor, his/her employees, guests or customers during the event. Vendor is hereby advised to carry insurance protection covering display materials against damage and loss and public liability insurance against injury in transit to, from, and within the confines of the vendor area, subject to the rules and regulations of the event.

5. Space Agreement: By signing this vendor agreement, the vendor agrees to abide by these rules and regulations and by the decisions of Valley Yoga Fest Committee with the understanding that failure to comply shall result in any agreement, whether written or verbal, to be considered null and void.

6. Refund: In the event Valley Yoga Fest, on the dates herein specified, is canceled or prevented by reason of inclement weather, we will refund the vendor fee in full.

7. HOLD HARMLESS CLAUSE:

Vendor shall assume all risks incident to or in connection with this Valley Yoga Fest and shall be solely responsible for damage or injury of whatever kind or nature, to person or property, directly or indirectly arising out of or in connection with the permitted activity or the conduct of vendor's operation. Vendor hereby expressly agrees to defend and save Valley Yoga Fest, its officers, volunteers, representatives and venue lessors harmless from any penalties for violations of any law, ordinance or regulation affecting its activity and from any and all claims, suits, losses, damages, or injuries directly or indirectly arising out of or in connection with the vendor activity or conduct of its operations or resulting from the negligence or intentional acts or omissions of vendor or its officers, agents, employees or representatives.
